The client agrees to hold Alex Brooks School of Dog Training harmless from any claims, actions, or demands against Alex Brooks School of Dog Training arising during the pick-up, transport, drop-off, and stay at Alex Brooks School of Dog Training.

The client authorizes Alex Brooks School of Dog Training to do whatever they deem necessary for the safety, health, and well being of the client's dog while under the care of Alex Brooks School of Dog Training.

This Addendum forms part of the Application and Agreement for Boarding and Training between the **ALEX BROOKS SCHOOL OF DOG TRAINING, INC.** ("Trainer") and _____ ("Owner")

1. Owner warrants that (i) he is the owner of the dog(s) which he desires to be boarded and trained by Trainer, and (ii) this application and agreement are complete and correct.
2. Owner agrees to pay the complete cost of boarding and training the dog(s) and other costs, all as provided for in this application and agreement.
3. Trainer agrees to exercise reasonable care in the boarding and handling of the dog(s) and to reasonably exercise his knowledge, experience and skill in training the dog(s) as provided for in this application and agreement.
4. Owner understands and agrees that the Trainer shall have no liability for the health and condition of the dog(s), except for that which is expressly undertaken in this application and agreement.
5. Should the Trainer believe the dog(s) are in need of medical care and believes that there is either insufficient time to contact the Owner or that the Owner is not readily available, then, in that event, the Trainer shall have the right to use the nearest licensed veterinary medical facility or other licensed veterinarian he elects. Owner agrees to pay all expenses incurred in securing such care and to indemnify the Trainer and hold him harmless for any such expenses. The Trainer shall not be liable for any injuries sustained by the dog(s) during the course of such medical care.
6. Following completion of the training program, Owner shall be entitled to one (1) follow-up training session, at no charge under this agreement. Owner acknowledges that the follow-up session is essential to the training program and agrees to return the dog(s) within thirty (30) days for it.
7. If this agreement is terminated without the Trainer's fault, then the Trainer may retain all advance payments received as liquidated damages. If terminated due to Trainer's fault, then Owner shall be responsible for pro rata share of boarding and training already received, with any excess payments being refunded to Owner.
8. Owner agrees to reimburse Trainer for reasonable costs, attorney's fees and the costs of litigation in enforcing this agreement.
